# STEELE PROPERTIES ADDS TO PORTFOLIO WITH \$18.3M ACQUISITION AND REHABILITATION OF HILLSIDE VILLAGE IN LONGVIEW, TEXAS

[Denver, CO, July 19th, 2023] Today <u>Steele Properties</u>, announced the \$18.3M acquisition and rehabilitation of Hillside Village, a Project Based Section 8, 100-unit community serving senior and disabled residents in Longview, Texas. This acquisition marks the nineteenth property in Steele's Texas Portfolio. <u>Monroe Group, Ltd.</u>, Steele's management partner, will oversee property management for the community.

Hillside Village will receive more than \$44,000 per unit in hard cost renovations as part of Steele's acquisition. Apartment homes will receive new flooring in kitchens and bathrooms, cabinet & countertop replacement, new kitchen appliances including refrigerators and garbage disposals, as well as new LED lighting throughout. Exterior upgrades will include LED lighting, HVAC replacement, parking lot and sidewalk repairs and ADA site work. The community spaces including the lobby, managers offices, community room/kitchen, business center and laundry room will receive much needed upgrades, as well as improved ADA accessibility throughout the community.

This project is financed with 4% tax credits awarded by Texas Department of Housing and Community Affairs, tax exempt bonds issued by Texas Housing Foundation, construction and permanent financing provided by KeyBank, and tax credit equity provided by CREA.

Principal of Steele Properties, Hud Karshmer shares, "We are excited to add to our growing portfolio with the addition of Hillside in Longview. We are grateful for our continued partnership with HUD, TDHCA, KeyBank, CREA and THF to provide necessary housing to the seniors and disabled residents of this community. We look forward to performing these needed upgrades to give the residents a place they are proud to call home for years to come."
